If held outdoors, MAP Parking, in or near driveway for loading of gear & adequate protection from all weather conditions. In the event that a performance cannot happen due to inclement weather, or local conditions of circumstances (Not under the control of Mac Live Entertainment) Mac Live Entertainment must still be paid in full!**
- 19) **If the Event is held outdoors, client must provide at least a 10' X 10' enclosed shelter to protect Mac Live Entertainment's Equipment & Personnel. If no shelter is provided, rain or shine, Mac Live Entertainment's equipment will not be set up until shelter has been provided. If shelter cannot be provided then Mac Live Entertainment will charge a separate price for set up, rental, and transportation of temporary shelter.
